Topics of discussion for the January 20th board meeting included increasing number of renewals for library items; a Services & Building Report covering needed light replacement for lights at the Atkins Centennial Library, and need to replace the 40-year-old roof at the Russellville Public Library (RPL). Director Pierce announced a "Rock 'N Read 5K for Literacy" to be sponsored by the Library Foundation on Saturday, March 12th, 2016 to raise funds for the Library System.

Additional topics included the Director's Annual Report: Volunteer hours, and programming attendance are up, State Aid is down.

Harkey Trust Fund: The RPL receives yearly funding from the Harkey Trust Fund to be used ½ for Capital and ½ for Library Materials each year. In 2015, the Market affected the principal by falling below \$1 Million. The Board discussed asking if check amounts could be based on income amounts only to keep the trust at the \$1 Million mark to protect the principal.

The PCLS now accepts checks in all of the Branches for fines, copies, book purchases, book replacements, etc. A total of \$8,177.45 has been raised for 2015's Book fund campaign with \$1,960.84 left to expend. Goal for the Book Fund Campaign for this year is \$25,000 which is the amount of State Aid cuts to the Library System for 2016.
