

ORDINANCE NO. 2018- 06**AN ORDINANCE SETTING THE SALARY FOR THE POSITION OF TREASURER OF THE CITY OF DIAMOND CITY, ARKANSAS; DECLARING AN EMERGENCY; AND FOR OTHER PURPOSES**

**WHEREAS**, the Constitution of the State of Arkansas, Amendment 56, Section 4, provides for the compensation of municipal officers; and

**WHEREAS**, Arkansas Code Annotated § 14-43-409 provides that such compensation shall be in the form of a salary and provided for by ordinance; and

**WHEREAS**, the City of Diamond City operates with a Mayor/Council form of government; and

**WHEREAS**, the City of Diamond City, Arkansas has never properly adopted an ordinance setting the salary for the municipal office of Treasurer;

**WHEREAS**, it is necessary to establish a salary for the municipal office of Treasurer for the City of Diamond City, Arkansas.

**NOW, THEREFORE, BE IT ORDAINED BY CITY COUNCIL OF THE CITY OF DIAMOND CITY, ARKANSAS THAT:**

**Section 1.** The salary for the Treasurer shall be \$16,900.00 per year.

**Section 2.** Pursuant to Arkansas Code Annotated § 14-43-409, in no instance shall any officer receive an additional compensation by the way of fees, fines or perquisites.

**Section 3.** The Treasurer shall not be entitled to receive any additional form of compensation or benefits, including health insurance coverage.

**Section 4.** This ordinance shall take effect immediately upon its passage.

**Section 5.** Any ordinance or part of any ordinance in conflict with this ordinance shall hereby be repealed and replaced or shall be held null and void.

**Section 6.** The provisions of this Ordinance are hereby declared to be severable and if any provision shall for any reason be held illegal or invalid, such holding shall not affect the validity of the remainder of the Ordinance.

**Section 7. EMERGENCY CLAUSE.** It is determined by the City Council that the adoption of this Ordinance is immediately necessary to provide clarity to potential candidates for the position of Treasurer, and to protect the interests of the citizens of Diamond City, Arkansas, and an emergency is hereby declared and this ordinance shall be in full force and effect from and after passage and publication.


