Vendors:

10x10 Booth Space:	\$50 / space
Each Additional 10x10 Space:	\$40 / space
Non-Profit 10x10 Booth Space:	\$35 / space

No tables, chairs, etc. are included. The fee is for space only. Must use blocks and weights to hold canopies or tents down; no stakes allowed.

Set up time will be May 30th, 9 am – 4 pm and May 31st, 7 am – 11 am. Security will be provided from Noon, May 31st through 11:00 pm, Saturday, June 1st. You will be required to be open and have your booth staffed from 4 pm – 8 pm on May 31st and from 10 am – 8pm on June 1st. We have entertainment through 10 pm that is expected to draw a large crowd. It is your option to stay open past 8 pm.

Guidelines & Regulations

Items restricted to sell: The Toes in the Grand Summer Kickoff Festival Committee has the sole and exclusive right to add additional items to the list before or during the Festival. The Committee, in its absolute discretion, shall decide at any time, before or during the festival, whether an item or product can be sold at a booth or on the premises. Should the Committee exercise this right and inform a vendor that an item or product cannot be sold; the item will immediately be removed from the booth or exhibit area and the festival premises.

Non-Food Vendors will not be allowed to give away or sell or any food or drink.

Fire, theft, damage: The Toes in the Grand Summer Kickoff Festival Committee and/or the Grove Area Chamber of Commerce will not be responsible for loss due to fire, theft, or other damage regardless of the cause. The Toes in the Grand Summer Kickoff Festival Committee and/or the Grove Area Chamber of Commerce is expressly released from any loss, injury, or damage to persons or property.

Use of vehicles & trailers as booth space: Trailers will be allowed for booth space at the discretion of the Festival Committee. Photos of the trailer must accompany reservation form.

Failure to comply with regulations will result in the exhibitor being dismissed from the 2019 festival and future festivals.

Application must include payment, City of Grove Vendor Form, and a copy of Oklahoma Sales Tax Permit, if you have one, to be considered complete.
