All students seeking Federal Financial Aid while attending Arkansas State University - Mountain Home during Summer 2019 need to complete this application. All students are encouraged to complete this application regardless of known eligibility remaining for Summer 2019.

To properly determine your eligibility for Federal Financial Aid for Summer 2019 at Arkansas State University-Mountain Home you must meet the following criteria.

- 1. Students seeking Federal Financial Aid for Summer 2019 must complete and submit this application to the Arkansas State University Mountain Home Office of Scholarships and Financial Aid.
- 2. All students must maintain Satisfactory Academic Progress through the end of Spring 2019. The Satisfactory Academic Progress Policy is online at <a href="maintain-assumh.edu/sap">assumh.edu/sap</a>.

**NOTICE:** All awards made for Summer 2019 prior to the end of Spring 2019 are subject to cancellation if Satisfactory Academic Progress is not maintained.

- 3. Be admitted to a financial aid eligible Associate's Degree or Technical Certificate program offered from Arkansas State University Mountain Home.
- 4. Be enrolled in courses that are required for the Technical Certificate or Associate's Degree you will be admitted to for Summer 2019.
- 5. Provide any additional documentation as requested by the Office of Scholarships and Financial Aid.

### Criteria 6 and 7 may have already been met during the 2018-2019 school year.

- 6. All students should complete the 2018-2019 Free Application for Federal Student Aid (FAFSA) and include the Arkansas State University-Mountain Home school code, 042544, on each application. The FAFSA is online at <a href="http://www.fafsa.ed.gov/">http://www.fafsa.ed.gov/</a>.
- 7. Complete the 2018-2019 Student Data and Title IV Authorization Form. This form is online at https://asumh.edu/financial-aid/financial-aid-forms.html.

### **PELL GRANT DELIVERY NOTICES**

Pell Grant delivery timing will depend upon when courses begin and if the student's Pell Grant is based upon new rules for year round Pell Grant.

- Pell Grant awards that <u>ARE</u> based upon federal rules for year round Pell Grant will not be delivered prior to the sixth
   (6<sup>th</sup>) aid eligible hour beginning. This could delay any Pell Grant delivery until the middle of July depending upon the
   individuals enrollment and eligibility.
- Pell Grant awards that <u>ARE NOT</u> based upon federal rules for year round Pell Grant, for course(s) that begin before June 6<sup>th</sup> are delivered in the middle of June, otherwise they will be delivered in the middle of July.

NOTE: A student being eligible for YEAR ROUND PELL GRANT depends on how much Pell Grant the student has or has not received during the preceding Summer, Fall, and Spring semesters. To be eligible to receive YEAR ROUND PELL GRANT, students must be in a minimum of 6 financial aid eligible credit hours in summer. The 6 credit hours do not have to be taken during the same time frame, but dropping or withdrawing from a financial aid eligible course before the 6<sup>th</sup> financial aid eligible credit hour begins will change a student's eligibility for YEAR ROUND PELL GRANT.

#### **PRIORITY SUBMISSION DEADLINE: May 1, 2019**

The Priority Submission Deadline is the date this application should be submitted and your file should be complete to give the Office of Scholarships and Financial Aid time for awarding Summer 2019 aid.
