BACKGROUND			
Federal regulations regarding the use of Title IV financial aid funds awarded to students provide that an institution may directly credit Title IV awards to a student's account at the institution to satisfy current charges for tuition and fees. Additionally, students may authorize ASUMH to apply any excess funds to satisfy other outstanding charges beyond tuition and fees, such as book voucher charges for the current and prior award years, or to hold excess balances for future charges.			
ASUMH policy requires students to pay or make payment arrangements in accordance with established tuition and fee due dates. In			
many instances, balances due for students receiving financial aid have been deferred based on the anticipated aid, however, those balances become due and payable to ASUMH immediately upon the disbursement of financial aid awards. In order to simplify and			
expedite the payment of outstanding balances to ASUMH, students should authorize ASUMH to directly apply Title IV and other			
financial aid funds to other outstanding charges which the student owes ASUMH for the current or prior years.

FEDERAL AID ELIGIBILITY

ALL applicants should:

- 1) File the 2018-2019 Free Application for Federal Student Aid (FAFSA) using school code 042544 at www.fafsa.gov.
- 2) Complete, sign and return this form.
- 3) Be **FULLY ADMITTED**, which means you have provided <u>ALL</u> of the following required documents to the ASUMH Admission Office including, but is not limited to:
 - a) Acceptance into a Financial Aid Eligible Technical Certificate or Associate Degree program at ASUMH. Certificates of Proficiency are **NOT** financial aid eligible.
 - b) A valid High School transcript or Home School transcript reflecting completion or acceptable GED test results.
 - c) Placement testing results such as ACT, SAT, ACCUPLACER or ASSET exam scores.
 - d) Final Academic Transcripts from <u>ALL</u> trade schools, colleges, and universities attended beyond high school.
 - e) Documentation of Measles, Mumps, and Rubella (MMR) shot records requirement.
- 4) Provide additional specified documents, <u>when and if requested</u>, by the ASUMH Office of Scholarships and Financial Aid to satisfy additional Federal Aid eligibility requirements.
- 5) Be Maintaining Satisfactory Academic Progress as defined at <u>asumh.edu/sap</u>.

REPAYMENT OF AID RECEIVED

Withdrawing from all courses when Federal Financial Aid is received results in a determination of eligibility for the aid. This determination of eligibility, known as Return to Title IV, usually results in a requirement to repay some or all aid a student receives. Simply stopping attendance is also considered withdrawing and also subject to a Return to Title IV determination. This does not include dropping a single class unless it is the only class remaining that a student is enrolled in.

PRIORITY CONSIDERATION DATE

The best way to ensure receipt of a Federal Financial Aid offer before a semester begins is to file the 2018-2019 FAFSA in early spring 2018 and provide all required documentation before the Date listed below.

Fall 2018: June 15, 2018 **Spring 2019**: October 1, 2018 **Summer 2019**: April 1, 2019

DIRECT STAFFORD LOANS

Stafford Loans are not automatically offered. If you wish to apply for Direct Stafford Loans, you must complete the ASUMH Direct <u>Stafford Loan Request Form</u>.
