- 1. Call to order: 9:02 am
- 2. Old Business
 - a. Minutes from the previous meeting
- 3. New Business items:
 - a. Update from the AI Workgroup:
 - The workgroup is revisiting the <u>student handbook</u> to see if the current student grievance procedure (page 28) needs to be <u>updated</u> to reflect ethical AI best practices.
 The Cheating/Plagiarism statements have been updated and approved. The Grievance statement is in the process of being updated to include AI specifically. It was suggested that the AI workgroup work with Brian on the revision. It was brought to attention that we don't use a specific statement for "Turn it in" so the question on whether we use language specifically for AI or more of a blanket statement to include all tools would be best.
 - The group has a <u>conference catalog</u> with AI webinars/conferences. Send conference information to Jessica, and check out the catalog to see if there is anything you are interested in. Karen shared the contact information for a speaker that will be presenting AI in K12 Education at MHHS and suggested that some members may want to attend.
 - iii. The group has surveyed faculty, and another survey has been shared with administrators and staff to gauge interest in learning about AI. We will be analyzing survey results and working on developing a comprehensive set of AI-related professional development options called the AI Institute. Our goal is to begin offering some professional development opportunities in fall 2025. Jessica Clanton has some paper copies of the faculty/staff survey if anyone needs one.
 - iv. The AI Workgroup is working with the Online Workgroup to develop a strategy for integrating AI applications with Canvas.
 - v. The <u>Al guidebook</u> is currently undergoing review and revision. Goals: Add student applications to the guidebook and address

sustainability issues around AI. Send suggestions to Jessica.
